Board Meeting Attendance:

Monthly Board Meeting:

The Board of Directors meet once a month to review the progress of objectives set at board retreats and to resolve operational issues. Board meetings must be held in the evening of the third Monday of every month except for the inaugural board meeting and the meetings that take place in the same month as board retreats. For re-scheduling of board meetings, a quorum formed by six incumbent directors is required to give approval.

Board Retreats:

There are two retreats each year. The first one should be held shortly after the new board has been elected, whereby board directors review objectives of the past year and lay down new objectives for the coming year. At the second retreat, board directors review successes or failures in carrying out the objectives made by them at the first retreat during the first half of their terms and make strategic plans for the rest of the year.
